TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entries are only open to Australian residents aged 8 years or over. Entrants under the age of 18 must have parent or legal guardian approval to participate in this Promotion.
